



Doubling your money!



How it works

Every pound that is donated to a Community Chest will be matched by the government with **another pound!**

They will also match the Gift Aid .

Therefore if you donate

£1.00 +28p Gift Aid = £1.28

The Community Chest will receive:

£2.56

If you donate:

£5.00 +28p X 5 Gift Aid = £6.40

The Community Chest will receive:

£12.80

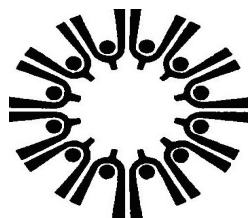
All money invested in the Community Chest will be invested to create a "Grant Pot" for future voluntary work.

Added Value
